Minutes of a Meeting of the Parish Council held on Monday 28th September 2015 in the upstairs room of Melbourn Community Hub at 7.15pm.

PC68/15 Apologies for absence:

PC69/15 To receive any declarations of pecuniary and non-pecuniary interest and reasons from councillors on any item on the agenda.

Cllrs Tulloch, Crosby, Bloomfield for PC75/15 declared a non-pecuniary interest as they are Directors of the Hub Management Company.

PC70/15 Minutes of the meeting held on 24th August, 2015:

IT WAS PROPOSED BY CLLR SHERWEN AND SECONDED BY CLLR LINNETTE THAT THE MINUTES OF 24TH AUGUST 2015 BE ACCEPTED AS A TRUE RECORD. THIS WAS CARRIED.

PC71/15 To report on the last meeting 24th August 2015

The Clerk reported on the following items:-

PC60/15: Due to Cllrs Bloomfield and Gatward absent from the meeting there
was a shortage of councillors to sign cheques. The Assistant Clerk confirmed she
would ask Cllr Gatward to sign the cheques separately after the meeting closed.
 Cllr Sherwen suggested another Cllr put themselves forward to act as a Cheque Signature. Cllr
Norman accepted this position. ACTION: THE CLERK TO ARRANGE FOR CLLR
NORMAN TO BECOME A CHEQUE SIGNATURE. This has still not been done.

- 2. PC61/15: Cllr Mulcock suggest Ian Dewer is contacted to confirm is there any procedure by NALC for this. ACTION: THE CLERK TO CONTACT IAN DEWER. This has not yet been done.
- 3. Stuart Cook confirmed the running costs of the computers and phone lines seem very high. ACTION: STUART COOK & THE CLERK TO INVESTIGATE. The Management Company pays the broadband and telephone bills. This is taken into account by the amount of money the Parish Council pays in rent.
- 4. To consider signs for Rose Lane and Dolphin Lane. This is under investigation.
- 5. The Clerk to send thank you letter to Helen Powell. This has been written and sent.
- 6. To ask MPC contractor to repair the damaged wall. This has been repaired.

PC72/15 To receive a report from County Councillor Susan van de Ven Melbourn Parish Council, September 2015, County Councillor Report

Cuts: I'm very sorry to say that the overall financial situation of the council is getting even worse and there is no relief in sight from central government. We must make 40% cuts over the coming five years. The council has consistently raised council tax to the maximum threshold permitted by central government, but costs arising from factors such as significantly declining government revenue support grant (which makes up a very large proportion of the council's expenditure) and an aging local population, which by definition demands an ever growing need for specialist services, means that it is impossible to make ends meet. Population growth in the greater Cambridge area, where unemployment is very low, triggers certain central government support, but this is limited and one-off capital funding cannot run public services.

The complaints I have received about lack of action to fill potholes and tend to drains (and even the failure to respond to faults logged on the County website system) reflect the fact that we are very short-staffed.

Health and social care budgets: This recently published article in the Guardian offers a very good synopsis of health and social care pressures in Cambridgeshire.

Community Transport and subsidized transport: I am chairing a small group that is being asked for a steer on budget cuts for community transport and bus subsidies, even though the bus subsidy transitions have not been completed, and even though we lack ridership data for those which have been launched. Community transport is an important component in providing transport to health appointments and we are working hard with Royston and District Community Transport to make the case. On a slightly more positive note, there could be some potential for collaboration with the Clinical Commissioning Group's imminent retendering of the Non-emergency Patient Transport Services contract, which is currently out for consultation. Please could the parish council respond? A10 Foxton—Harston cycle path: Work has started and will take about 20 working weeks. Funding comes from the Dept for Transport (not the Council). This is the first phase of the overall project; the other big phase will be work on the route through Harston itself. The fact that mental health and cycle paths are being funded reflects a rise in mental ill-health, and also the obesity crisis, which has the power to further deplete the public purse. Cllr Stead expressed his annoyance at the traffic delays this was causing. This was supported by Cllr Gatward who complained about the time taken to get to Addenbrookes.

Bike Bank – funding has been secured for another round of the Bike Bank bicycle maintenance course, to be offered free of charge to Melbourn area young people who will attain employable skills. The thought is to target slightly older teens, so recruitment will also take place at Cambridge Regional College, Long Road and Hills Road Sixth Forms, in addition to MVC. Outspoken, the deliverer, will run recruitment. MAYD is asked to receive the funding from the Department for Transport and issue the payment to Outspoken on completion of the course. Also as a result of the Dept for Transport 'Local Sustainable Transport Fund' grant, a free Dr Bike session will take place at the Melbourn Hub on 17 Oct, 1-4.

Skanska and High Street survey: Unfortunately in spite of multiple calls to Skanska by Cllr Hales and myself, Skanska has not come back on the High Street survey, discussed last month.

Norgetts Lane, Water Lane, one-way systems: I understand that the parish council will be discussing

street line painting tonight; would it please include a plea for refreshed line painting for these two roads where the one-way system is being ignored – thank you.

Rail User Group and Melbourn access to Meldreth Station: Thanks to Cllr Barrett and Cllr Hales for taking the time to attend the Rail User Group meeting earlier this month. The long-term goal of improving access to the London-bound platform has not been successful; to have a chance at rail industry funding of a ramp, the right of way public path over private land needs upgrading and this requires landowner consent and also a positive push from Meldreth Parish Council.

On a positive note, contactless ticketing will be available on both platforms within a few months and this will improve accessibility.

Meldreth Station gardening takes place the morning of October 7 and any donations of plants, or helping hands, would be welcome.

Orchard Gate: I've been contacted again by residents asking if anything can be done about the poor state of the pavement and road surfaces, which make it difficult for people confined to wheelchairs and mobility scooters to get about confidently. There has been some patching done but essentially not much has changed. Unfortunately Orchard Gate is not exceptional and I've not been able to get it onto the list for capital repairs.

A related idea concerning improvements for the sake of mobility of those less who are less agile, was raised by a resident of Maple Way who says that in his mobility scooter heading to the village centre, the segment between Orchard Gate and New Road could use a pair of dropped kerbs to enable mobility scooters to continue off-road. Car parking in that stretch means that pulling safely into the road is not possible. Is this something that the parish council would consider, perhaps through Local Highways Improvement grants?

This matter will be referred to the Highways Committee which will consider applying for a local Highways Improvement Grant.

Practical Solutions Group (PSG) meets tomorrow – are there any issues the Parish Council would like raised? We will be looking to support the next Celebrating Ages tea, and various activities around Melbourn Area Youth Development.

Hub Public Services for all: I wondered if and when the Melbourn Hub might be considering making a request for funding contributions from neighbouring parishes to help cover the cost of hosting public services at the Hub?

The Clerk and Stuart Cook to write to the surrounding parishes asking them to consider making a contribution to the Community Hub for services which are provided in the Hub which are used by residents of the surrounding villages.

The appeal on the 199 houses is going ahead. The next Melbourn Futures Committee meeting will be held on 8th October at 10.00 a.m. in the Hub at which Philip Kratz will be present to talk about the appeal.
