(TEMPORARY 40MPH AND 10MPH SPEED LIMIT)
ORDER 2017/649**

NOTICE is given that Cambridgeshire County Council has made an Order pursuant to the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, the effect of which is to stop any vehicle from proceeding along various roads as set out in Schedule 1 below.

Nothing in this Order shall prevent access and egress from premises or land adjacent to the highway mentioned in Schedules 1 and 2.

The alternative routes are shown in Schedule 1.

The Order is necessary for safety reasons to facilitate essential carriageway maintenance works.

The proposed Order will come into operation on 1 November 2017 and will continue until the essential maintenance works have finished or on the 30 April 2019 whichever is the earlier.

It is anticipated that this order will apply to the locations, at various times during the dates specified in the Schedules.

The Order shall not apply to any persons lawfully engaged in connection with any works for which it is made, any member of the Police Force, Fire and Rescue Service, Ambulance Service, a vehicle being used by Special Forces during the execution of their duties or to any person acting with the permission or upon the direction of a Police Officer in uniform.

**Application for Temporary Traffic Regulation Order at Various Roads,
South Division**

Your application for the above Order has been approved, and will come into operation on 1 November 2017.

All necessary legal procedures have been attended to by ourselves, the emergency services will be informed in due course and you will be invoiced accordingly.

Will you please note that the proper signing of the road obstruction in accordance with Traffic Safety regulations and the adequate signing of the alternative route are entirely your responsibility. You MUST place Notices at least 1050mm by 750mm at each end of the highway to be closed at least 14 days prior to the closure informing the travelling public of the start and end dates of the closure. .

All signing must be carried out to the entire satisfaction of the Local Infrastructure and Street Officer (Telephone Number 0345 045 5212) in whose area the work lies and you should make early arrangements to discuss the signing with him.
