	All activities away from your normal location must be risk assessed and notified to the district commissioners
	nominated person (Stuart DDC) 7 days in advance with a copy of the activity risk assessment including Covid risks for that activity.
Notes	All Risk assessments must be shared with all your leaders and any helpers that help you on an activity and with
	the youth members for example explorer you might showing them the risk assessment and read over it, for
	beavers and cubs you would during the rules and instructions tell them what things are dangerous, for
	example at camp they could be told they are not allowed in the kitchen but also tell them why, ie there are hot pans and boiling water that could burn them. It important to give the reasons so they know the risks to help
	them develop their own safety skills as they grow up into adults.
