6.	For what purpose of project is the grant requested.	At present we have areas within our play space that are potentially hazardous, such as irregular paving. To improve the outside provision of the setting, we would like to resurface the area with wet pour safety surface. All children access the outside area and a new surface is also needed to enable climbing equipment to be placed outside. This resurfacing will enrich the outside space for more accessible and creative play.

7.	What will be the total cost of the above project?	We have received three quotations. The one we would like to proceed with is £12,556.20. This is from Online Playgrounds.

Surfacing Materials

Fibrefall – (Bonded Shredded Rubber Chippings)



Fibrefall is an all-weather rubber surfacing constructed with resin bonded recycled colour coated rubber chips which is laid to existing ground contours and can be installed to comply with the current surfacing standards of EN1177. Available in either Green, Brown or Cedar Red, Fibrefall provides a continuous surface and can be installed onto a wide range of substrates including turf, tarmac and concrete, and benefits from requiring minimum basework preparation and no formal edging. Applications include impact areas, all weather surfacing and pathways.

Wetpour Rubber is a hard wearing all weather safer surfacing which can be used for a wide range of applications including play areas, pathways, sports surfacing and other all-weather applications. It is available in a wide range of colours and can be designed with unique graphics layouts. Wetpour is usually installed onto an engineered subbase, retained by a kerb edging and is laid in 2 parts – A base course of recycled rubber and a fine 20mm topping of EPDM rubber. Our surfacing has undergone and continues to undergo extensive independent testing to ensure that our Wetpour surfacing complies with all current British and European Standards of Surfacing EN1177.

-  Good access will be available to the site.
-  Are amenities available on site? If amenities are not available for our team to use, an additional £173.00 will be added to the final invoice.
-  It is assumed that the current base is stable.

-  All equipment and surfacing complies with EN1176 and EN1177.
-  All our equipment is installed with Critical Fall Heights (CFH) compliance to EN1176/EN1177 /EN16630.
-  Once the equipment and or the surfacing has been installed and handed over we take no responsibility for any damage through abuse / vandalism or acts of god that may occur.
-  Our quotation is open for acceptance for **30 days** from the quotation date.
-  All materials and guarantees are referred to in our product specification.
-  Security fencing can be supplied and erected at extra cost if deemed necessary by the customer.
-  We will accept NO responsibility for detecting services or I.T cables etc. These should be clearly marked by others before any installation work commences.
-  Suspension bridges, Burma bridges, single ropes and access nets are designed for a maximum of 1 person crossing at any one time; however additional people can be waiting to cross on the timber structures.
-  Guarantees:
 - 15 Years on all structural timbers against rot and timber decay – subject to the outer treatment envelope having not been damaged. (Dry rot is NOT covered)
 - Timbers cannot be guaranteed against rot and decay when installed into loose fill wood product surfacing. (Dry rot is NOT covered)
 - Please be aware that in the case of Black Wetpour surfacing, colour fastness cannot be guaranteed, and some colour leakage may occur.
 - 1 Year on all moving and flexible parts. 1 Year on all installation work (*Malicious damage, vandalism and acts of god are not covered*)
-  Layout drawings and plans to be agreed and signed by the customer prior to the product being manufactured if an order is placed.
-  If the Wetpour cannot be laid because of incomplete base works a charge of £1,100.00 per day will be incurred.
-  The colour of our Fibrefall surfacing will darken after a period of time as the vibrancy of the colour coating diminishes.
-  Ownership of goods remains the property of Fenland Leisure Products Ltd until invoice is paid in full.
