Diana Hedley provided an overview of the report. Noted that the consultation was successful with video presentation being well received. Groundwork were unable to deliver 3 sessions due to covid restrictions (invoice adjusted accordingly). No response from KJA in Royston following request to consult students. Some consultation was online which allowed students outside of MVC to participate.

Outcomes of the consultation were discussed. Noted that obstacles to attendance include transport and location.

Discussion as to Groundwork's suggestions for future delivery.

- The suggestion of a Gaming Café was well received and noted this may provide opportunities for addressing online safety as well as gaming.
- Cooking activities always popular but would depend on facilities available.
- Sports and outside activities good options for summer months.

- Schools may already offer sports activities through after school clubs youth club needs to offer something more such as coaching or multi-sports.
- Noted that young people's responses did not suggest a preference for specific sports and that interest may be in spectating as well as participating in sports.

Noted that timing of youth club is an important factor. Younger students seem to prefer activities directly after school. Need to ensure youth club is not seen as simply an extension of after school clubs.

Gaming Café:

- Noted that young people use gaming as a social activity this would also offer opportunities for addressing online safety.
- Locations were discussed and it was noted that the pavilion does not currently have wifi but other venues may be available.
- Resources for gaming would be required. A member noted that Meldreth Covid Response Team had great success following a call for donations of laptops. Other suggestions for equipment were PS, Xbox and Switch. Good wifi would be essential.
- More traditional board games are also popular.

Noted that Groundwork have recruited a new youth worker for Melbourn. There is also one sessional worker. A further team member to be recruited prior to resuming youth club. Noted difficulties with recruiting for evening staff at this time.

Discussion as to restarting youth club. Suggested after Easter to allow for staff recruitment. Suggested that youth club should restart on a more structured basis initially with workshops etc. Other outside activities could take place as the weather improves.

Further research into options for transporting young people to other villages is required to make youth club more accessible and inclusive.

Melbourn Youth Provision: Youth Consultation 2021

Prior to Covid-19, Groundwork re-launched Melbourn Youth Club in January 2020 to tackle some of the challenging behaviour seen at the club and as a result the new club was developing well. Sadly, due to the pandemic and in light of the various restrictions, the Melbourn Youth Club had to close and over the last year Groundwork tried a number of interventions to encourage youth engagement. This included online delivery, projects and outdoor events, which were met with different levels of success. In recent discussions between Groundwork and MAYD, it was felt that since the pandemic and lack of interaction with young people, we no longer understand the needs of the young people in the area. In order to be able to provide future provision that meet the needs of young people, Groundwork propose delivering a youth consultation in Autumn of 2021. The consultation will be delivered in two parts and will culminate in a report highlighting the feedback along with suggestions for future delivery. A suggested timeline for this consultation will be Mid-September to the end of October, but this will depend on the availability of the Melbourn Village College and if restrictions in school still apply.

The consultation will ask young people a variety of questions to help understand what is needed in the area, including, but not limited to;

- Location
- Time
- Types of Activities sports, art, music
- Types of provision youth club, projects, outdoor
- Age groups
- Specific issues or interests
- Barriers to attending
- Best ways to publicise provision

Groundwork will work with MAYD to agree questions, which will be used in both the face to face consultation and online survey to ensure continuity of results.

Face to Face Consultation

Groundwork will deliver 5 face to face sessions at Melbourn Village College for years 7-11. This will include an assembly to each year group, followed by a lunchtime stall in the area of good foot traffic. The assembly will introduce the students to Groundwork and MAYD and explain the purpose of the consultation. It will go on to explain how the young people can take part and where to find the youth workers at lunchtime. During the lunchtime, Groundwork will set up an interactive stall somewhere easily accessible to the students. Young people will be able to access the stall throughout lunch to answer questions and give feedback. To encourage involvement, a small gift such as a packet of sweets will be given to all those taking part and as a wider incentive for both the face to face consultation and online survey, young people can submit their name and email for a chance to win a £50 youcher.

Online Consultation

Alongside the face to face consultations, Groundwork will run an online survey. The online survey will be accessible to all those that can't take part in the face to face consultation and can be circulated to other schools in the surrounding area. Finally, Groundwork will circulate the survey via social media and to all voluntary groups in the area to encourage as many young people as possible to give feedback.

Melbourn Youth Consultation Report

The Consultation

Groundwork was funded by MAYD to deliver a two-part youth consultation in school and online over the October and November period. Groundwork planned to deliver four assemblies and lunchtime sessions at Melbourn Village college and one assembly and lunchtime at King James' Academy in Royston. The consultation provided young people with the opportunity to feedback on what youth provision they would like to see in the area. For those unable to take part in the face to face consultation and to ensure as many people as possible could provide feedback, an online version of the survey was created.

On communication with Melbourn Village College, Groundwork learnt that assemblies were no longer taking place at school to reduce the number of young people congregating at one time. Instead, the school requested that Groundwork supply a video to play to the students in their form time. The video would provide details on who Groundwork and MAYD were, the aim of the consultation and where the team would be during the lunchtime sessions. Groundwork were happy to oblige; however, this caused a slight delay in the lunchtime sessions going ahead, as it took time to produce the video.


During the consultation Groundwork was located in an outside space on the school grounds, in between the key areas of years 7,8 and 9 during lunchtime. The consultation was set up to provide young people with the opportunity to take part in an interactive questionnaire, where they could discuss their answers with the youth workers on hand and add to a wall of questions using stickers and post-its. All those who took part in the face to face consultation then had the chance to win a prize from our punch wall, where they could pick a cup, punch through the paper and receive their prize. This was a great success and the first two sessions saw a buzz of people interacting with the staff and taking part. Sadly, after the first two sessions, due to the rise in Covid-19 cases, the school had to stop the face to face sessions and external partners were no longer allowed in school. To encourage more young people to take part in the online version to the survey, Groundwork adapted the video and provided a QR code to the school. This meant that the young people could learn about the online survey and then access it directly using the QR code on their phone. The school used this information in form time to encourage young people to take part and sent the information directly to parents. Groundwork also sent the video and information to King James School in Royston, who also were unable to allow external visits.

In all 56 young people took part in the survey, 38 face to face and 18 online. Had the consultation been delivered in its entirety, we believe Groundwork would have been able to engage with over 100 students in total. This demonstrates how powerful face to face work is and how positive providing young people with a voice is. Despite not completing the consultation sessions as planned, Groundwork was pleased with the number of young people who interacted in the sessions and the information received. All those who took part were also given the opportunity to provide a contact email in order to be put forward to win an amazon


voucher. This provided another incentive to take part either in school or online and created a fantastic contact list for Groundwork and MAYD to communicate new provision with the young people.

Below are the results from each of the questions asked in the survey, followed by suggestions of what provision could be offered by Groundwork in response to the young people's needs.

Consultation Results




The results show that providing youth provision early in the evening or after school is more preferable, although an evening slot is also popular. By providing a session after school, specifically if the provision can be located on the school grounds, would attract young people and may also tackle some of the barriers highlighted later in the consultation, such as transport and location, as the students from Melbourn Village College would have good access after school.




Other - games like truth or dare.


As we have seen in the past, sport is still a keen interest for young people alongside cooking. This suggest that young people would engage in these targeted programmes of activity.




A split age group is more desirable, although there isn't much difference between the two responses.



This question provides some very interesting results including more detail on the types of sport young people are interested in and also the growing interest in gaming. This highlights some exciting opportunities for youth provision specifically over the winter when it maybe harder to offer sports outside.




The key topics young people want to explore in the area include friendships, LGBTQI+, school and bullying. Interestingly friendship was the highest, which could be a direct result of Covid-19 and the impact it has had on young people's lives. The top four demonstrate the need for youth provision and a safe space for young people to meet people, learn how to build strong trusting relationships, learn how to behave and treat others and explore who they are.



Other - after school clubs

Location and transport are key barriers stopping young people from access provision in the Melbourn area. This is not surprising as many of the young people live in the surrounding villages or Royston and would therefore have to travel to Melbourn for any provision. In the past, Groundwork has explored offering provision in a range of different locations, which would be possible for some of the activities provided later in this report. However, as many of the young people will come directly from Melbourn Village College, one way to combat this would be to hold an after-school provision in the building on the school grounds (if available), allowing easy access after school and reducing the need for two-way transport.



Other - posters

As we see with many young people, Instagram is still the most popular mode of communication. Groundwork already has an Instagram account for Melbourn Youth Provision providing a great platform to advertise any future provision. Groundwork has also recently acquired a new system called Hubspot that allows us to streamline all marketing, including timetabling regular posts on all social media platforms and sending out regular personalised mailouts ensuring we could communicate with parents and young people alike. We would also continue to use posters and leaflets in school.

Suggestions for future delivery

The following suggestions for future delivery are based on the results of the consultation and past experience and knowledge of the area, location and facilities Groundwork have available to them.

Winter Provision

Option 1 - Youth Gaming Café

If the building on the school grounds is available and suitable, Groundwork will offer a 1 night a week youth gaming café. A safe space for young people to come and relax after school and take part in a range of games including computer games, board, games, puzzles and quizzes alongside computer-based activities such as support with homework and further education. This would be a mixed age group session, allowing ease of access after school to ensure the barriers of transport and location are reduced. All games will be age specific and will focus on team working rather than an individual gaming experience. The gaming cafe will provide a space to discuss and support internet safety, friendships and school. Simple refreshments will be offered and older young people can take on volunteer roles to run the café element. Workshops will also be held on subjects such as CV writing, preparation for further education and preparation for work. There will be a considerable initial cost to equip the club with gaming and computer facilities and this would only be possible if the venue is suitable and has the IT infrastructure. However, it will provide a very new and exciting steer on a generic youth club, drawing on our ever-growing digital lifestyles, ensuring that young people are able to meet face to face in a safe environment whilst still being part of the growing online community.

Option 2 – 6-week project-based sessions

Similar to what has been offered in the past, during the winter months Groundwork will provide a variety of 6-week projects to young people covering the interests and topics highlighted in the survey such as cooking, sports, friendship and bullying. A location would be chosen dependent on the needs of the activity and could happen afterschool or later in the evening. Sessions would be split by age and bookable to ensure maximum engagement.

Summer Provision

Option 1 – Sports sessions and mini youth club

During the summer months, Groundwork will offer a sport focussed youth provision based at the Pavilion to make full use of the green space during the good weather. Groundwork will organise a sports coach to deliver activities on the green each week. Alongside this, two youth workers would engage with any other young people in the area through outdoor games and simple activities. The pavilion itself would be open for toilet and kitchen use.

Option 2 - Sports Tour

Groundwork will offer a sport focussed youth provision as outlined above in a variety of different locations, so that every few weeks or each month Groundwork will visit a different village.
