Good afternoon

My apologies for the time it has taken for us to reply.

After Speaking with we approached a couple of contractors to advise on the best course of action for the area.

Both agreed that we could create a wider turn for your driveway to allow for cars to be parked on your property more easily. This would follow the plan as attached – creating a flat area of hard standing to the end of the current bed to allow cars to pass over and then reinstating and improving the rest of the bed. The shrubbed area (or what remains after works) has also been added to the village maintenance map so would be tended to annually.

From our discussions it was suggested that you could be removing the run of shrubs that are on your land (directly in front of the house) to allow you more space. If this is the case we propose that we work together, at the same time, with any improvement works to ensure you reach the result you are looking for.

At a recent Maintenance Committee Meeting it was decided to take the quotes we have received as a baseline and offer to work with you to resolve the issue. We believe we would be looking at investing a maximum of £2,000 into the project.

Please take a look at the rough plans attached and let us know if they align with your thoughts. I look forward working with you on a plan.

## Homeowners shrubs

From land registry plans it looks as though the run of shrubs along the front of the house belong to the homeowner.

Proposal is for homeowner to remove these to allow for space to park 2 x cars on the driveway.
